Rhea called the meeting to order at 1:05 PM, noting no changes to agenda.

Larry moved to approve the minutes from the July 18, 2018 regular meeting. The motion was approved unanimously.

Board business

Financial Officer's report: See Appendix 1 and 4.

The following voucher/warrants/electronic payments are approved for payment: Claim numbers: 18030 through 18037, totaling \$34,625.29; and July (\$15,212.29) and August (\$14,275.68) payrolls.

Facility Manager's monthly report: See Appendix 2. David advised that to resolve traffic congestion in the Garbage Area from people using TIOLI, he was closing three (3) parking spaces to the public. In addition, he said the purchase of a red tippler in the Recycling Area for disposal of ½ bags of garbage to further relieve congestion in the Garbage Area was in process.

Training, Education and Outreach Coordinator's report: See Appendix 3. To accommodate her schedule, the Agenda was adjusted to allow Nikyta to report. After submitting her report, she reminded all of The Great Island Cleanup on September 29.

Administrator's report: The Daily Bale Report (Appendix 6) was reviewed. Garbage volume continues to increase and the market for recycling continues to fluctuate greatly.

District Manager's monthly report: See Appendix 4. The Plastics Committee has been working diligently to try to find a solution to the lack of a market for recycled plastics and has considered every possible option. LSWDD is at the end of the road in terms of plastics supply chains and it is unaffordable/unattainable for us to reasonably recycle these plastics without the help of a larger partner like Skagit Steel, who has been reluctant to support our effort for numerous practical reasons of their own. After discussion, Larry moved the following: Effective November 1, 2018, the LSWDD will remove the Mixed 1-7 plastics tippler from the recycle plaza and accept these materials as garbage only (including film and ag plastics). The motion passed unanimously. We hope to salvage plant "planters" in specific sizes from the general ag plastics stream and continue to provide these for reuse. We also have begun salvaging bubble wrap for reuse by local businesses. If new opportunities for reuse or sale of certain plastics in the 1-7 stream present themselves, we can salvage these specific types as well into a specialty bin.

Other reports

Solid Waste Alternatives Program See Appendix 5. This report was reviewed and approved.

New business: Paul lead a discussion of the Preliminary 2019 Budget. A special Board meeting will be called to finalize the 2019 Budget during the first two weeks of October, date and time to be determined. Paul next led a discussion of the issues involved in possible LSWDD site expansion.

The meeting was adjourned at 2:50 pm. The next regular board meeting is October 17, 2018. Paul will send out the board packet.

SAFETY

The bollards at the Zwall have been re-painted with traffic yellow paint for better visibility.

GENERAL

OPERATIONS/ONGOING ISSUES:

Public Works is implementing a new work schedule arrangement beginning this Fall. The semi-annual switch from a four day work week to a five day week will be replaced with a quarterly work schedule arrangement which includes a 4 1/2 day work week in the Fall and Spring seasons. Beginning September 24th, the shop will switch to a nine hour day Monday through Thursday with a half day on Friday.

Since the 21st of September falls on a Friday this year, the change to Fall/Winter/Spring hours for the facility will happen the following weekend. Signs notifying the customers of the change were posted at the facility two weeks ago. Bill Clemens has updated the LISSY schedule with the new shift times.

David has replaced the failing old backhoe bucket with a newer one donated by Tim Arnold. The old bucket had become worn and cracked beyond practical repair. Pape' Machinery will be sending a representative to Lopez Island this week and David has requested an assessment and repair estimate for the backhoe unit.

Page Read has repaired a portable air compressor for the facility to use.

Cascade Containers has begun construction of our new rolloff container for glass collection. The new container will be of heavier construction and feature a cover with four access doors on each side. The side walls will also be lower to allow easier tipping for customers. A medium shade of brown was chosen for the paint and the unit should be completed and delivered to the Skagit valley for pick up in October.

The Galley restaurant has begun using our "Early Gate" service for weekly recycling and garbage disposal. Historically the Galley has been a recycle customer with only occasional garbage disposal.

A second 90 gallon recycling container has been added to the recycle line for the collection of clean bubble wrap for re-use.

Skagit River Steel and Recycling has not mailed the invoice for August as of this writing. Prices from the July invoice are as follows:

August 2018 Board Report -- Training, Education and Outreach Coordinator

Training / Volunteers: See August volunteer analysis (below).

Training & Recruitment:

- 2 new Volunteers in line to be trained this month as part of Y2Z.
- Continuing to work with District Manager on updated posters for volunteer recruitment posters.
- Recruited a new volunteer scientist, Ben Kaas for Plastics Solutions Committee
 Meeting, and as working expert for 3D printing and ReMake Lab. He is faculty at
 Western University and will also help arrange Lopez student tours for ReMake Lab
 participants in the Fall.

Education:

- Y2Z updates posted on website and FB page, added to end of summer newsletter.
- Y2Z blogger and Lopez student Hazel Arden took a 3 week long zero waste challenge in the Spring, and was our first blogger for Y2Z. She has also participated in LSWDD educational experiences, like the Creative Reuse Salon, since age 12. She is now 16 and a barista at Lopez Coffee Shop. She was horrified to see how much waste single use coffee cups produce, and came up with a new solution: to divert reusable mugs, both ceramic and to-go plastics from TIOLI and offer them for free at Lopez Coffee Shop. Owner approved implementation and Hazel will blog

- about results for Y2Z. It is important to note that this is a student led community solution!
- Working with Lopez teachers and citizens to recruit volunteers for participation in September's "Evolving Cities" at the Pacific Science Center with the ReMake Lab in it's current R & D and about LSWDD in general for a focused weekend called "Evolving Cities".
- Arranged time to present to 3rd grade class of Lopez School students with presentation PSC. New ReMake Lab students will hopefully be able to attend.

Events:

- Preparations for PSC in September.
- Preparations for Fix it Café now rescheduled for November.

Outreach:

- Have contacted 50 Lopezians: teachers, students, parents and volunteers to recruit
 and educate about PSC event. This has the added benefit of keeping the ReMake
 Lab in the forefront of the community.
- Y2Z is having an effect, as Lopez Coffee Shop has implemented new composting solutions, has eliminated trash bags from their waste stream (3000 a year!) and is continuing to offer both mason jars for Lopez reuses, and now free cups and mugs.
- Y2Z: Holly B's Bakery looked into reducing plastic waste also, and is now utilizing a reuable plastic "sleeping bag" for croissant dough instead of individually wrapping each ball in cellophane.
- To spread this news, we have included messages on Lopez Rocks directing readers to LSWDD website and FB for Y2Z blog postings.

Ongoing:

- Lopez Island Tool Lending Library waiting for next meeting time.
- PR Committee published 1 newspaper articles, Y2Z programming, FB and publications.
- Plastics Committee: met and has added a new member, Ben Kaas who is faculty at Western University and the expert on 3D printing, specialty filaments, and has a degree in Polymer Science.

TIOLI: Georgeana and Monte Cook are now part of monthly TIOLI meetings as they are doing so much organizationally, and diverting usable items off islands in personal volunteering.

1. Financial Updates – Monthly and YTD summary:

Summary:

We were 22% below budgeted revenues for August (roughly \$8,000; attributable to both a late excise tax receipt from San Juan Sanitation (\$3,500) and some August revenue being accounted for in September by the county). We are at 100.2% of budgeted revenues for the year to date. August expenditures were 6% above budgeted (largely attributable to Professional Services contract with Povl Lasbo paid this month that was not budgeted). Year to date expenditures are 2.5% below budget.

We are holding \$200,000 in investments.

We have \$28,829 in our cash account; \$228,829 total.
